Task Force Newsletter

At the <u>July 25, 2024</u> meeting of the Texas Impaired Driving Task Force, the Executive Committee provided the following updates.

Retail Enforcement and Education: 2024 Spring Break Operations

The Texas Alcoholic Beverage Commission's Spring Break operations take place in March, when thousands of students from across the U.S. flock to Texas beaches and entertainment districts.

Type of Operation	Description	Number of Operations
Undercover Operation	Focused on detecting underage and intoxicated-related offenses. May include cooperative retail operations (e.g., COPS, fake-out).	254
Underage Compliance Operations	Undercover operation to identify businesses that sell alcohol to minors.	1983
Open/High Visibility Inspections	Visible presence during large events to deter criminal activity.	1468

These operations resulted in 92 Administrative Violations, 87 Criminal Violations, and 9 Arrests.



It is crucial for local police agencies to coordinate with the Texas Alcoholic Beverage Commission (TABC) before initiating any operations related to alcohol enforcement. By proactively engaging with TABC, your local agency can ensure that its operations are not only effective, but also fully compliant with state regulations.

Impaired Driving Data

The National Highway Traffic Safety Administration (NHTSA) has recommended that Texas establish an impaired driving database. This initiative will be complex and will require data and input from multiple sources. To move forward, the Texas Impaired Driving Task Force (TxIDTF) and the Texas Traffic Records Coordinating Committee (TRCC) will collaborate to draft a memo outlining the rationale for creating such a database.

Stakeholders will also address several key aspects, including:

- 1. **The contents of the system:** What data and information the database should include.
- 2. **Administration:** Who will be responsible for managing and operating the system.
- 3. **Location:** Where the database should be housed and maintained.
- 4. **Data integration:** How to effectively merge data from various sources, ensuring that public information and protected data are combined appropriately while maintaining confidentiality and security.



Impaired Driving Enforcement Training and Detection

TxSFST Fiscal Year 2024 Program Highlights

The Texas Standardized Field Sobriety Testing (TxSFST) Training Program aims to enhance the administration and consistency of DWI investigations and enforcement by offering FREE training to licensed Texas peace officers. The program's mission is to reduce alcohol-

related crashes, injuries, and fatalities by advancing DWI deterrence and enforcement skills.

Texas DRE Fiscal Year 2024 Program Highlights


The Texas Drug Recognition (DRE) Program is funded by a grant from the Texas Department of Transportation. It focuses on training, managing, and promoting the International Association of Chiefs of Police (IACP) Drug Evaluation and Classification Program (DECP). The DECP is a systematic, 12-step evaluation used to investigate drivers suspected of impairment by substances other than, or in combination with, alcohol.

The program offers FREE DRE School and recertification courses to eligible Texas peace officers. The DRE School is structured in three phases: Pre-School, a 7-Day School, and the Certification phase. Upon completion, officers receive 152 hours of TCOLE credit. Additionally, the program supports the development of local DRE programs by providing administrative guidance and best practice policies for using DREs in impaired driving and other investigations.

Since Carlos Champion, DRE State Coordinator, assumed leadership of the DRE program in Texas in October 2021, there have been significant increases in the number of DREs in the state:

The number of DREs in Texas has grown by 30 percent since October 2021, bringing the current total to 422. The number of agencies with at least one DRE has risen by 28 percent since October 2021, with 134 agencies now having a DRE on staff.

In 2023, 643 evaluations were conducted, marking a 31 percent increase compared to 2022.

BeABlake Foundation Honors Carlos Champion

Jackie Rhone, Founder and CEO of <u>BeABlake Foundation</u>, delivered a powerful keynote address, emphasizing the foundation's commitment to combating drug-impaired driving and enhancing community safety. During the presentation, Carlos Champion, the dedicated TxIDTF Executive Committee Member and DRE Program Manager, was honored with the "BeABlake Award." This

Manager, was honored with the "BeABlake Award." This accolade recognized Carlos's unwavering passion and dedication to educating law enforcement professionals with the ultimate goal of eradicating drug-impaired

driving across Texas.

The award presentation was made even more special by the presence of Kailey, Blake Rhone-Subinsky's daughter, who joined Jackie in presenting the honor. Blake, a radiant individual whose life was tragically cut short on August 31, 2021, due to a crash caused by a drug-impaired driver, is remembered through this award and the impactful work of the foundation.

Carlos Champion and Jackie Rhone have been collaborators in the fight against drug-impaired driving, working together to promote the Texas DRE Program and support officers seeking to become DREs through the BeABlake Foundation's travel scholarships. This initiative aims to bridge the gap for agencies lacking the resources necessary to facilitate officer training, thereby advancing their shared mission to ensure safer roads and communities.

Subcommittee Updates

Cannabis & Alcohol

The TxIDTF has identified hundreds of businesses in Texas that permit on-site consumption of both THC (hemp-derived cannabinoids) and alcohol. This contrasts sharply with other states where adult-use cannabis consumption is allowed, but the sale and consumption of alcohol at the same location are generally prohibited. Some states even bar businesses from holding both liquor and cannabis licenses simultaneously. Maryland recently became the latest state to ban alcohol consumption at licensed cannabis lounges. To address this issue, the TxIDTF has established a subcommittee focused on educating policymakers of this important issue.

Several bills will be introduced in the 2025 legislative session aimed at regulating hemp-derived products more effectively.

Recently, an interim legislative charge from the Lt. Governor's Office has tasked the State Affairs Committee with examining the sale of intoxicating hemp products. The committee is expected to recommend measures to further regulate these products and prevent their marketing to children. It is anticipated that several bills will be introduced in the 2025 legislative session aimed at regulating hempderived products more effectively. The Cannabis & Alcohol Subcommittee, along with the Legislative Subcommittee, will monitor these bills closely.

Offenders with limited English proficiency who are assigned to court ordered alcohol education face substantial challenges with the communication needs required to complete a course.



Language Barriers

The problem of language barriers in court ordered alcohol education was initially presented to the Texas Impaired Driving Task Force by Judge Hand, Potter County Court at Law #2. Offenders with limited English proficiency who are assigned to court ordered alcohol education face substantial challenges with the communication needs required to complete a course. Further complicating the matter is that instructors and program managers struggle to develop and distribute learning materials to students who lack or have limited ability to communicate in English. The TxIDTF convened a subcommittee to further discuss the issue of equity in DWI Education probation requirements for non-English/Spanish speakers.

The Language Barriers Subcommittee undertook an investigation to:

- 1. Identify the barriers to effective communication for defendants ordered to attend court-mandated alcohol education.
- 2. Assess and recommend solutions to address the language barriers faced by both instructors and participants in these programs.

The subcommittee's inquiry included a review of state regulations governing court-ordered alcohol education, instructional delivery methods, accommodations for non-English speaking learners, and alternative teaching methodologies. The findings led to the following recommendations:

- Asynchronous Virtual Education Delivery: Implement a system allowing participants to learn at their own pace using online resources (e.g., videos, slides, audio) through a learning management system (LMS). This approach would require updates to current Texas Department of Licensing and Regulation (TDLR) policies, including adjustments to administrative requirements for asynchronous delivery.
- Recommended LMS: The Canvas Learning Management System was identified as a suitable platform. Canvas supports both synchronous and asynchronous training and offers a centralized system for efficient content translation with extensive language options.

• Language Prioritization: Use census data to prioritize languages that will effectively reach large populations of offenders needing court-ordered alcohol education.

The subcommittee recommends that the TxIDTF continue collaborating with TDLR and judicial associations to explore the development of a virtual solution hosted on an accessible LMS. This solution aims to provide court-ordered alcohol education in a variety of languages to accommodate a diverse population of offenders.
